Why would a simple fall, infection or near drowning leave a person in a vegetative state (VS), minimal conscious state (MCS), or locked-in state? What are the subtle differences between a diagnosis of a MCS and VS that make the crucial difference in the assessment, care and rehabilitation of a person who the public classify as "vegetables" and yet the book "Le Scaphandre et le Papillon" (The Diving Bell and the Butterfly) was written by journalist Jean-Dominique Bauby while he was in a locked in state.

The Sensory Modality Assessment and Rehabilitation Technique (SMART) was co-developed by Helen Gill-Thwaites and Rosalind Munday, and was considered in the recent case of **W v M (2011) EWHC 2443**. SMART is referred to by the Working Party of the Royal College of Physicians in its Report on "Prolonged disorders of consciousness National Clinical Guidelines" published towards the end of 2013.

The course will start with a short video of how SMART is applied and provide an outline of the different levels of consciousness and how they are assessed. The judgment in **W v M** will then be considered and its consequences as well as ethical issues and what the new RCP guidelines recommend.

 - Varies states of consciousness Definitions, preconditions and criteria for Coma, VS and MCS
