He is a Deputy Director of the Asian Institute of International Financial Law (AIIFL) and a member of the editorial board of the Hong Kong Law Journal. Mr. Meggitt is a member of the Hong Kong Law Society's Insurance Law Committee and also a former director of the Hong Kong Insurance Law Association.

## Course Outline:

This course covers the operation and regulation of the insurance market in Hong Kong, including under the new Independent Insurance Authority; the doctrines of 'Insurable Interest' and 'Utmost Good Faith'; specific terms of insurance contracts and how they differ from those in other contracts; how claims are made by policyholders and dealt with by insurers; the rights of insurers, including subrogation and contribution; and the role of insurance brokers and agents.
