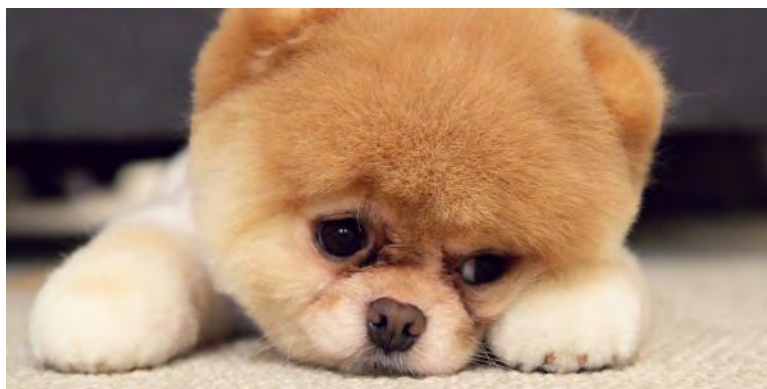


Admissions, Without Prejudice Privilege and the Apology Ordinance
