

The Law of Charities in Hong Kong and Possible Reform

This 3-hour seminar will provide an introduction to the existing law of charitable trusts in Hong Kong and the legislative changes to this area of the law that were proposed in 2013. The seminar will begin with consideration of the existing law of charitable trusts in Hong Kong, including the benefits of charitable status for a trust and the requirements for charitable status. The seminar will then consider the problems with the modern law of charitable trusts in Hong Kong as identified in the Law Reform Commission's public consultation report published in 2013 and the recommendations on proposed legislative changes.
